COMMITTEE ON ETHICS

January 2023

The Committee on Ethics (Committee) continued to fulfill its responsibilities to advise and educate Members and staff on the laws, rules, and standards of conduct. As a general matter, the Committee's activities in receiving and responding to requests for advice from House Members and staff are conducted on a confidential basis. In January 2023, the Committee responded to nearly 1,900 phone calls and email messages seeking advice, and participated in many informal meetings with Members, House staff, and outside individuals or groups regarding specific ethics matters. The Committee also received 24 requests for formal advisory opinions.

In accordance with the Rules of the House of Representatives for the 118th Congress, the Committee continued to review and approve requests to accept privately-sponsored, officially-connected travel. The Committee received 173 new requests for travel beginning in January or later. Thirty-one House employees traveled on a Committee-approved privately-sponsored, officially-connected trip within the month of January.

The Committee is required under House rules to offer mandatory annual ethics training to each Member, Delegate, Resident Commissioner, officer, and employee of the House. The Committee is working to modernize its guidance in both substance and method of delivery. The Committee continued to provide training in January through live and on-demand offerings, and released a Pink Sheet announcing Two Upcoming Live, In-Person Ethics Training Sessions for January and February. One hundred twenty-five individuals attended live in-person training hosted by the Committee on January 24. The Pink Sheet is available here. As part of a Committee-wide effort to better promote compliance through clear and effective guidance, the Committee created and launched a Periodic Transaction Report (PTR) Due Date Calculator to assist Members with calculating filing due dates if transactions and notifications occur on different days. The Committee issued a Pink Sheet announcing the launch of this new feature and summarizing the PTR requirement with more clear instructions, new charts, and tips for success. The PTR calculator is available here. Prior general advisories and pink sheets are available here.

The Committee also issued a 2023 PRINT of the Highlights of the House Ethics Rules with CY2023 thresholds and triggers. The 2023 PRINT of the Highlights is available on the Committee's homepage here.

The Committee issued a summary of its activities for December 2022 directed to the Committee on House Administration. This statement is publicly available on the Committee on House Administration's website.
