Of this NOA, no funding requires additional notification, as it remains consistent with information notified via the FY 2022 Congressional Budget Justification (CBJ), and there are no special notification requirements.

CN - DFC will provide technical assistance ("TA") grant funding in an amount of up to \$1,000,000 to establish a Customer Voice Technical Assistance Facility ("Customer Voice TAF") in support of the design, implementation, and interpretation of end-customer surveys for eligible DFC clients to enhance the developmental impact of

investments and to strengthen clients' business and impact performance. This activity will use up to \$1,000,000 and is expected to use FY 2022 appropriated funds in this amount to fund this technical assistance grant.

CN –State DDTC 21-020, notification of certification of the export of defense articles, including technical data, and defense services, to Mexico to support the manufacture, test, inspection and rework of parts and components of various gas turbine engines.
