H.R. 259, the "Post-Disaster Assistance Online Accountability Act."

To provide for an online repository for certain reporting requirements for recipients of Federal disaster assistance, and for other purposes.

Passed the House under suspension of the rules by voice vote.

January 25, 2023:

H.R. 346, the "NOTAM Improvement Act of 2023."

A bill to establish a task force on improvements for notices to air missions, and for other purposes.

Passed the House under suspension of the rules by a $\frac{2}{3}$ recorded vote of 424 yeas and 4 nays (Roll No. 34).

January 25, 2023:

H.R. 388, the "Securities and Exchange Commission Real Estate Leasing Authority Revocation Act."

A bill to amend title 40, United States Code, to eliminate the leasing authority of the Securities and Exchange Commission, and for other purposes.
