Chairman Frank Pallone, Jr., Subcommittee Chairs and other House and Senate Leaders

April 6, 2021 – Chairman Pallone, along with Bobby Scott, Chairman of House Committee on Education and Labor, Richard Neal, Chairman of House Committee on Ways and Means, Patty Murray, Senate Chair of Committee on Health, Education, Labor and Pensions, and Ron Wyden, Senate Chairman of Committee on Finance, wrote to Hon. Xavier Becerra, Secretary of the Department of Health and Human Services, requesting the Secretary to implement health provisions in the American Rescue Plan Act of 2021 (ARPA) to make available Special Enrollment Period that will allow unemployed workers to maintain access to affordable coverage.

April 13, 2021 – Chairman Pallone along with Ranking Member Cathy McMorris Rodgers, Subcommittee on Health Chairwoman Anna G. Eshoo and Ranking Member Brett Guthrie wrote to Hon. Xavier Becerra, Secretary of the Department of Health and Human Services, regarding implementation of the Hospital Price Transparency Final Rule to conduct oversight and enforce full compliance with final rule give the widespread non-compliance by hospitals.

April 19, 2021 – Chairman Pallone along with Ranking Member Cathy McMorris Rodgers, Subcommittee on Communications and Technology Chairman Mike Doyle and Ranking Member Robert Latta wrote to the Evelyn Remaley, Acting Assistant Secretary of Commerce for Communications and Information, National Telecommunications and Information Administration (NTIA), to express support of NTIA leadership on matters of federal spectrum management.

April 28, 2021 – Chairman Pallone, along with Ranking Member Cathy McMorris Rodgers, wrote to Hon. Katherine C. Tai, United States Trade Representative, expressing concern over inclusion of language resembling Section 230 of the Communications Decency Act of 1996 in any trade agreements while Congress is seriously considering modifications to the statute.

On April 22, 2021, the Subcommittee on Health held a bipartisan teleconference briefing for its members with Peter Marks, M.D., Director of the Center for Biologics Evaluation and Research at FDA and Amanda Cohn, M.D., Chief Medical Officer for National Center for Immunization and Respiratory Diseases at CDC. The topic of the teleconference was the focus on recommendation for a pause in the use of Johnson & Johnson COVID-19 vaccine.
