CN #24-71 — Pursuant to the reporting requirements of Section 36(b)(1) of the Arms Export Control Act, as amended, we are forwarding herewith Transmittal No. 24-71, concerning the Navy's proposed Letter(s) of Offer and Acceptance to the Government of Japan for defense articles and services estimated to cost \$150 million. We will issue a news release to notify the public of this proposed sale upon delivery of this letter to your office.

CN #24-140 – DFC will provide an equity investment of up to \$75,000,000 to Copenhagen Infrastructure Growth Markets Fund II SCSp (the "Fund"), a targeted \$3 billion renewable energy infrastructure fund, with a primary focus on solar photovoltaic and wind (onshore and offshore) greenfield projects. The Fund will focus its investments across select markets in South and Southeast Asia, Latin America, Central and Eastern Europe, as well as in South Africa. The Fund expects to develop 10GW of renewable energy across these select markets, which is expected to power the equivalent of more than 10 million households annually.

CN #24-141 – DFC will provide a five-year, 80 percent guaranty to Goldman Sachs Bank USA ("GS Bank") for a \$225 million MXN-equivalent loan to Konfio, a financial technology non-bank financial institution ("NBFI"), with a digital-based business model that exclusively serves small businesses in Mexico. The DFC guaranty will enable Konfio to: (i) secure a facility with a longer tenor with GS Bank bearing 20 percent of direct risk of the loan and (ii) expand its small business loan portfolio with at least 30 percent of the proceeds earmarked for women-owned or led small businesses. By providing more access to growth capital to 4.8 million underbanked small businesses in Mexico, Konfio will be able to make a more significant contribution to financial inclusion and economic development in Mexico.

This notification is submitted on behalf of the Bureau of Political-Military Affairs. The \$75,474,000 will support FMF programs included within the State Africa Regional Operating Unit for ARCT for Cameroon; State Central America Regional for Belize; and FMF programs for Estonia, Georgia, Latvia, Lithuania, and Morocco.

CN #24-301 – Consistent with sections 7004(b), and 7015(b) of the Department of State, Foreign Operations, and Related Programs Appropriations Act, 2024 (Div. F, P.L. 118-47) ("FY 2024 Act"), and section 34 of the State Department Basic Authorities Act of 1956 (22 U.S.C. 2706), the Department of State is notifying its intent to award construction contracts to fit out leased space, improve building systems, build an American Center, replace blast resistant windows, and reprogram \$209.6 million from Capital Security and Maintenance Cost Sharing projects and available resources within the Other Worldwide Security Upgrades program. In addition, consistent with section 5112 of the National Defense Authorization Act (NDAA) for Fiscal Year 2022 (P.L. 117-81) and as amended in NDAA for Fiscal Year 2024 (P.L. 118-31), we are notifying our intent to purchase art that will be displayed within newly constructed buildings.

CN #DDTC 24-066 – Defense articles will be temporarily transferred into Syria by Mainspring employees, under contract with DoD to support U.S. military operations in Syria. DoD requires personal protective equipment (PPE) and chemical detection and decontamination equipment (CDD) for Mainspring employees in Syria to ensure safety from ballistic and chemical threats. The defense articles subject to this report will remain in the possession and control of Mainspring personnel at all times. There is no intent to leave the defense articles in Syria or to transfer the defense articles to Syrian persons.

CN #262 – This narrative describes programs that USAID/Niger intends to carry out using fiscal year (FY) 2023 new obligation authority (NOA). CN #24-142 – DFC will provide a direct loan of up to \$15,000,000 to Global Partnerships Impact-First Fund 9.0, LLC (the "Borrower"), a fund designed to support investments primarily motivated to address the needs of people living in poverty (the "Project"). The Borrower is an investment vehicle that will use DFC funding to make senior debt investments in social enterprises in the Latin America and Sub-Saharan Africa regions.

CN #24-301 – The Department of State is notifying you of its intent to obligate Fiscal Year (FY) 2023 Assistance for Europe, Eurasia, and Central Asia (AEECA). This notification is being submitted on behalf of the Office of the Coordinator of U.S. Assistance to Europe and Eurasia. The \$13,625,050 is to support countering violent extremism, democracy, and economic growth programs in the Europe, Eurasia, and Central Asia region.
